Business Promoting Education Member Commitment

- The member business agrees to organize, promote, and present one educational course during its membership year.
- The specific topic of the course is at the discretion of the business. However, the topic must be educational in nature.
- The course must be open to all local in-home childcare providers. No provider can be excluded due to agency affiliation, age, sex, or ethnicity.
- The member business must make a substantive effort to include all in-home childcare providers in the area, not just those associated with the business.
- The course must be offered free of charge.
- Businesses may work together to offer required courses, providing one course is offered for each participating business (i.e. two placement agencies and a tax service work together to provide a day of professional development for nannies, offering a course on tax issues, Shaken Baby Syndrome, and positive discipline).
- The member business must submit an event summary within 30 calendar days of the event.
